## Where is the Class of 2006?

A little more than four years ago, the Alumni Association awarded our first scholarships to the Class of 2006. This class headed in many directions following graduation, with many attending college in New York or beyond. Of the 39 graduates who received our scholarship that first year, we will focus on 3 recipients. It won't take long to realize that 2006 scholarships have been put to good use.

**Lee Gabler** has achieved success in the classroom, athletic arena, and beyond during his time at SUNY Geneseo. Most recently he was named a Presidential Scholar. To receive this honor, a student must hold a minimum GPA of 3.6, demonstrate academic achievement across the curriculum, and demonstrate an active involvement with the community. Lee has also been named to the Dean's List in every one of his semesters at Geneseo. In addition to maintaining the highest standards academically, Lee has also excelled athletically. He has been named to numerous All-Conference teams in Track and Field as well as Cross Country. Most recently he was named as an All-Atlantic Region runner in Cross Country and was a member of Geneseo's cross-country team that finished 7th at the 2010 NCAA Division 3 National Championships.

**Linnaea Chapman** attended Hamilton College where she had a wealth of experiences and opportunities. In the summer of 2008 she studied rare species at the Rome Sand Plains with two biology professors. She was an Outing Club officer and led backpacking trips in the Adirondacks. As a member of

the Hamilton College Choir, she toured Italy in 2009. Linnaea also studied in Paris for a semester as a way to use her French skills and experience another culture.

After many wonderful experiences, Linnaea graduated in 2010 with a major in Biology and a minor in French. She recently worked for Grassroots Campaigns Incorporated canvassing for the Nature Conservancy and has just started as a Sample Prep Technician at Brooks Rand Labs, an environmental lab that tests for mercury and other heavy metals. Linnaea is presently considering advanced study options and plans to attend graduate school in the near future.

**Zach Pratt** graduated Magna Cum Laude from St. Michaels College in 2010 with a major in Computer Science and a minor in Math. At St. Michaels Zach was involved in drama as an actor/senior director and the a cappella group Mike Check. Zach received department top honors at graduation and was a member of the Dean's List (every semester) and three Honor Societies. These included Phi Beta Kappa, Math Honor Society, and St. Michael's Honor Society. Presently Zach is at the University of Iowa School of Law pursuing his Juris Doctorate. He would like to practice law in the area of Intellectual Properties.

# THS Alumni Honored

On July 30, 2010 four Ticonderoga High School alumni were honored with awards during a special ceremony.

Recognized with 2010 Ticonderoga Alumni Association Distinguished Alumni Awards for outstanding career success and service to their community and society were Donald Dedrick and Sanford Morhouse, Esq.

## Donald B. Dedrick

Donald B. Dedrick, a 1939 THS graduate, distinguished himself as a pilot in WWII and the Korean War. He later transferred to the Coast Guard and served on search and rescue missions. Donald retired as a commander in 1981.

In addition to building and maintaining his highly successful insurance business, Donald took time to serve his community in many meaningful ways. The list is extensive, and these are only highlights:

# Scholarship Award Now Available to Military-Bound Seniors

Graduates of Ticonderoga High School who choose to enter the military are now eligible to participate in the Alumni Association's Scholarship Award Program. Starting with the class of 2011, students who opt for the military will be given a financial award based on academic achievement, attendance, good citizenship, extracurricular activities, community service, and family involvement. As with other awardees, funds can be collected when students successfully complete their first semester at a college or technical school.

The Alumni Association Board of Trustees made this change based on the fact that the expanded benefits of the New GI Bill make military service a real stepping stone to advanced schooling, and on the desire of the Board to recognize and honor the sacrifices of young people who are willing to protect our nation.

## 32 Seniors Share \$14,000 from Alumni Association

Thirty-two members of the Class of 2010 applied for and were eligible to receive a total of \$14,000 from the Alumni Association. The awards ranged from \$272 to \$499, with an average award of \$437.

The awards are determined by a student's academic achievement, good attendance and behavior, extra-curricular activities, community service and family involvement. The scholarship awards are paid upon the students' successful completion of their first semester at a college or technical school.



## Ticonderoga Middle School Lauded

College for Every Student (CFES), a nonprofit organization dedicated to helping underserved youth gain access to and succeed in college, recognized Ticonderoga Middle School as a School of Distinction for the 2009-2010 school year. The Middle School was lauded for its exemplary mentoring program which involves students, community members, and athletes from Middlebury College, its student leadership initiatives, and its efforts to make students aware of college opportunities at an early age.

CFES works with over 120 schools and 15,000 students across America. Ticonderoga was one of only 14 schools to achieve School of Distinction status. CFES also works with teachers and students at Ticonderoga High School. Last year, THS students visited several colleges, helped organize a Career Day at the school, and coordinated a removal of invasive plant species from the LaChute River Trail.

# Ti High Teacher Honored

Rick McClintock, a THS math teacher for 23 years, was recently honored with a special award: the AP Award from the College Board. This award, given to 4 teachers annually in the Middle States Region extending from New York to Washington, D.C., honors teachers for accomplishments in the Advanced Placement Program.

The AP program offers college-level courses and exams at high schools. Students can earn college credit with quali-

fying scores. McClintock's students have a history of outstanding scores on exams (scored 1-5) with most scoring 4 or 5. McClintock has stated, "Those aren't my test scores; they are the scores of my students." Former student Ben Chapman who nominated McClintock noted: "He let us know what he expected out of us. If you're in his class you're there to get a 4 or 5. He pushed us to be our very best."

## In Memoriam

### Florence Hahn Osier

1911-2010

After graduating Nursing School in 1932, Florence became certified as a Public Health Nurse and began her service as a school nurse in Saugerties NY. From 1943, until she retired in 1971, she was the school nurse at Ticonderoga Central School.



### Honorable James Preston King

1929-2010

A 1947 THS graduate, Judge King graduated from Westminster College and received law degrees from Albany and George Washington University. He served in the Marine Corps and was promoted to Brigadier General, becoming the Corps' highest ranking JAG officer. Following his military retirement, he served as law clerk to State Supreme Court Judge Dominic Viscardi, served as Assistant Attorney General of NYS, and as an adjunct professor at Albany Law School. In 1990, Judge King was elected (and re-elected) to the State Assembly (109th A.D.). In 2005 Jim was recognized as one of the inaugural recipients of our Distinguished Alumni Award.
